SECTION III: NARRATIVE

BILL SUMMARY

Senate Health and Public Affairs Committee Substitute for SB 87 removes the language previously added to Section 10-11-7(C) paragraphs 1 through 4 and adds language to Section 10-11-8 by the addition of paragraphs J, K and L to the section.

Paragraph J provides that a retired member may be subsequently employed by an affiliated public employer; provided that the retired member has not been employed as an employee of an affiliated public employer or retained as an independent contractor by the affiliated employer from which the retired member retired for at least ninety consecutive days from the date of retirement to the commencement of subsequent employment or reemployment with an affiliated public employer in specifically identified positions, addresses contributions paid by on or behalf of the retired member during subsequent employment, seniority and states there is no limitation on the length of time the retired member can subsequently be employed.

Paragraph K provides that a public employer that employs a retired member shall track and document information related to that employment and also addresses that if the affiliated public employer has to lay off employees due to budgetary restrictions, the layoff of reemployed retired members before laying off any members.

Paragraph L provides definitions for retired members are eligible for reemployment.

FISCAL IMPLICATIONS

In this substitute, the fiscal impact remains the same as SB87. The bill does not include CYFD employees, resulting in no fiscal impact to the agency.

SIGNIFICANT ISSUES

This committee substitute for Senate Bill 87 does now include juvenile correctional officers, but does not include juvenile probation officers or protective services investigators. Inclusion of juvenile probation officers and protective services investigators in the bill would benefit CYFD for the same reason the bill benefits the state's law enforcement departments.
