#### **BILL SUMMARY**

#### Synopsis:

- 1) Senate Bill 130 establishes a nine-member "Work Group on Artificial Intelligence Systems" to develop legislative proposals and recommended policies for the use and procurement of artificial intelligence systems by the State. Agencies will cooperate with the work group, including providing information, data, records and reports regarding an agency's use or procurement of artificial intelligence systems upon request.
- 2) The work group must meet a minimum of four times a year.
- 3) By November 1, 2025, the Work Group will submit a report of its activities and recommendations to the Legislative Finance Committee (LFC), the appropriate legislative committee focused on science and technology issues and to the Governor.
- 4) \$500,000 is appropriated from the General Fund to the Cybersecurity Office for staffing and support services for the artificial intelligence work group. Any unexpended or unencumbered balance remaining at the end of fiscal year 2026 shall revert to the General Fund
- 5) The effective date of the provisions of SB130 is July 1, 2024.

#### FISCAL IMPLICATIONS
