### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Synopsis: Senate Bill 175 creates a new section of law authorizing the Department of Finance and Administration (DFA) to establish a program to distribute funds for state and local law enforcement officer, correctional officer, and probation and parole officer recruitment. Appropriates \$35 million (GF) to DFA for use in FYs 2025 through 2027 for recruitment.

DFA is to establish criteria for disbursement of funds to the state and local law enforcement agencies, the Corrections Department and the Administrative Office of the Courts for law enforcement officer, correctional officer and probation and parole officer recruitment. The agencies may use the funds to recruit certified law enforcement officers, certified correctional officers and probation and parole officers.

#### FISCAL IMPLICATIONS

Senate Bill 175 appropriates \$35 million to DFA, until rules are developed by DFA, exactly how this fund would work and what funding would be available is unknown. This could be a useful funding source since NMCD did not receive the increase requested in the Training Academy budget for recruiting efforts and if DFA allows, may be a source to help fund salaries and benefits if allowed. As this bill covers a large group of potentially eligible entities, it is unknown at this time how much would be allocated for correctional and probation and parole officers.
