#### SECTION III: NARRATIVE

#### **BILL SUMMARY**

<u>Synopsis:</u> SB 204 enacts a new statutory section to create the fourth degree felony crime of Unlawful Carrying of a Firearm in a Park or Playground, consisting of carrying a firearm in a park or playground except be a:

- (1) Peace officer;
- (2) Security officer licensed and allowed to carry a firearm pursuant to the Private Investigations Act; or
- (3) Member of the armed services or reserve forces of the United States or the New Mexico National Guard while performing official duties.

SB 204 defines "firearm," "park" and "playground."

#### FISCAL IMPLICATIONS

There will be a minimal administrative cost for statewide update, distribution and documentation of statutory changes. Any additional fiscal impact on the judiciary would be proportional to the enforcement of this law and commenced prosecutions, and appeals from convictions. New laws, amendments to existing laws and new hearings have the potential to increase caseloads in the courts, thus requiring additional resources to handle the increase.

#### SIGNIFICANT ISSUES

- While SB 204 defines "firearm" to mean a weapon that will or is designed to or may readily be converted to expel a projectile by the action of an explosion, including a handgun, rifle or shotgun, Section 30-7-16 NMSA 1978, governing the receipt, transportation or possession of firearms or destructive devices by certain persons, defines "firearm" to mean, "any weapon that will or is designed to or may readily be converted to expel a projectile by the action of an explosion or the frame or receiver of any such weapon".
- 2) On September 8, 2023, Governor Lujan Grisham issued an executive order suspending open and concealed carry, with the expressed purpose "to try to create a cooling-off period while we figure out how we can better address public safety and gun violence." The ban was soon narrowed to apply only to parks and playgrounds, in Albuquerque and Bernalillo County.

In early January, 2024, the justices of the NM Supreme Court heard oral arguments in a lawsuit brought by Republican state legislators, the National Rifle Association (NRA) and others, challenging the emergency orders. The justices have yet to issue a ruling. 1) Should SB 204 become law, it is likely that it will be subject to challenges under both the Second Amendment of the U.S. Constitution and Article 2, Section 6 of the Constitution of New Mexico.

In addition, and as the Office of the NM Attorney General pointed out in its analysis of 2023's HB 101 and its substitute, the court in *New York State Rifle & Pistol Association v. Bruen*, 597 U.S. \_\_ (2022), held that the government must demonstrate that the regulation being challenged is "consistent with this nation's tradition of firearm regulation," meaning, explained the New York Times, "that the constitutionality of modern gun control measures depends on whether the government can show that there were analogous laws during the 18<sup>th</sup> and 19<sup>th</sup> centuries."
