SECTION III: NARRATIVE

BILL SUMMARY

This bill follows a recent federal court ruling that preliminarily favors the constitutionality of current executive and public health orders banning members of the public from carrying firearms at parks and playgrounds. The purpose of this bill is to protect New Mexicans by prohibiting members of the public from carrying a firearm in a park, playground, or adjoining parking area. With clearly carved out exceptions, including peace officers, licensed security officers, members of the armed and reserve forces and the New Mexico national guard performing official work, this bill addresses public safety concerns while allowing military and law enforcement professionals maintain access to their firearms as part of their essential peace keeping responsibilities.

As defined by the bill, a park means outdoor recreational area, open to the public, owned or managed by a municipality or county. The bill specifically provides for the use of firearms at an outdoor shooting range, distinguishing it from the given definition of a park. A playground is defined as an outdoor facility open to the public owned or managed by a municipality or county, and references play stations and climbing structures alongside slides, swing set intended for the recreation of children. For a violation of this safe parks and playgrounds bill, a fourth-degree felony would apply.

SIGNIFICANT ISSUES

New Mexico has experienced high rates of gun violence with deaths attributable to firearms increasing in the state by 43% over the 18% national average from 2009 to 2018. Most alarmingly for children and teens, guns are the leading cause of death in New Mexico and shootings have led to the loss of life for a thirteen-year-old girl, a five-year-old girl, and an eleven-year-old boy in various communities across the state. Mass shootings have increased in the state and gun violence continues to cause physical and emotional harm and long-lasting consequences for all too many New Mexicans. Public healthcare systems have been over-burdened by gunshot victims in the state. This bill addresses the problems relating to gun violence in the state by focusing on increasing the safety for New Mexicans and their children in highly frequented public recreational spaces.

DPS plays a significant role in maintaining public safety in parks and playgrounds across New Mexico. Passage of this bill would ensure children, families, and recreationists' safe enjoyment of the state's protected outdoor play areas.
