### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

### Synopsis:

This bill would direct the local government division of the Department of Finance and Administration to work with local governmental entities and federal agencies to provide a report to the LFC and the governor regarding efforts by the state for damage caused by the Black fire, including the actions taken, the cost of those actions, projections of remaining fire recovery needs.

The bill would appropriate \$1 million from the General Fund to DFA for expenditure in FY2025 through FY2027 for Black fire recovery efforts; provided that up to \$50,000 of the appropriated funds may be used for staff and related administration costs for the efforts. Any unexpended or unencumbered balance remaining at the end of FY2027 would revert to the General Fund.

#### FISCAL IMPLICATIONS

The bill is not expected to have any significant fiscal impacts for NMSLO.

#### SIGNIFICANT ISSUES

The 2022 Black Fire burned over 325,000 acres in the northern Black Range in Sierra County, Catron County, and Grant County, Northeast of Silver City. The New Mexico State Land Office (NMSLO) estimates that only approximately 400 of the burned acres were state trust lands, and those effects were of "low" or "unburned" severity.

This fire impacted rural populations during a year that was overshadowed by the Hermit's Peak/Calf Canyon Fire. The ranching community, including those whose acreage includes state trust land, suffered from the detrimental impacts resulting from high severity fire and subsequent flooding. These impacts include roads that continue to be impassable, fences that need repair, and on-going watershed concerns such as erosion and sedimentation. Funding would help accelerate recovery for these rural populations.

### ADMINISTRATIVE IMPLICATIONS

There are minimal administrative implications for NMSLO, depending on whether NMSLO is

provided any funds or recovery efforts as a landowner, and is asked for information for reporting purposes.

# CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

### **TECHNICAL ISSUES**

It may be appropriate to include state agencies (including NMSLO) in the list of cooperating entities, which would involve amending the language of Section 1 to read:
