BILL SUMMARY

Synopsis:

Senate Bill 250 (SB250) enacts the Innovation Fellowship Act, establishing innovation fellowships to support graduate or post-doctorate students from the University of New Mexico (UNM), UNM Health Sciences Center, New Mexico State University, the New Mexico Institute of Mining and Technology, and Navajo Technical University who have filed applications for patents with the United States patent and trademark office for inventions with the potential to create new commercial enterprises.

The bill creates the Innovation Fellowship Fund to award innovation fellowships, to be administered by the Higher Education Department (HED). The bill makes a nonrecurring, nonreverting appropriation of five million dollars (\$5,000,000) from the general fund to the Innovation Fellowship Fund. A Fellowship Selection Committee is also created to consult with HED on implementation of the Act.

The legislation allows a maximum of ten fellowships per year, with restrictions on the number of applicants from any one named university, and covers all tuition and fees, a living stipend of twenty thousand dollars per year, a travel reimbursement of up to five thousand dollars per year and a maximum of fifty thousand additional dollars to further develop the fellow's patent and commercial enterprise. Fellows are required to show a binding commitment to establish a commercial enterprise in New Mexico upon the success of the patent, or if sold, repay the amount awarded by the Innovation Fellowship Act.

The bill stipulates that universities of selected fellows who are post-doctoral employees will be reimbursed one-half of the fellow's annual salary to allow for time to be dedicated to the patent commercialization and enterprise development.

The bill also stipulates that the Fellowship Selection Committee award fifty thousand dollars (\$50,000) per fiscal year to each of the four named higher education institutions to offer entrepreneurship education programs to students.

SIGNIFICANT ISSUES

Supporting and increasing the patenting, licensing and commercialization of technology and innovation developed at New Mexico institutions of higher education is an important aspect of growing the science and technology sectors in the state and diversifying the state's economy. Making funds available to further support New Mexico students pursuing innovation commercialization relatively early in their careers could increase the amount of patents granted to New Mexico technology and contribute to the growth of the state's economy.
