#### **BILL SUMMARY**

<u>Synopsis:</u> This bill proposes an appropriation of \$500,000 from the general fund to the board of regents of New Mexico State University. The allocated funds are intended for expenditure in fiscal year 2025 and subsequent fiscal years to hire a sports nutritionist who will provide consultation services to the university's women's sports teams. Notably, any unexpended or unencumbered balance at the end of a fiscal year will not revert to the general fund, ensuring continued support for sports nutrition services beyond the specified fiscal period.
