SECTION III: NARRATIVE

BILL SUMMARY

SJR2 (Very similar to 2021 SRJ7; 2020 SJR3; 2019 SJR6; 2018 SJR1; 2017 SJR9) Amends Art. 12, Sec. 13, of the Constitution of New Mexico to provide for nominating committees for all appointed and reappointed members of Boards of Regents of New Mexico Public Higher Education Institutions (HEIs) except student members.

The New Mexico Higher Education Department (NMHED) analysis of this bill focuses on the higher education implications of the proposed legislation. Additional insight may be obtained from other agencies' analyses.

FISCAL IMPLICATIONS

SJR2 may have fiscal implications if the Legislature were to determine through legislation that a nominating committee should receive compensation and/or reimbursement. SJR2 may have a fiscal impact on the Legislature, HEIs, or state agencies depending upon how the Legislature chooses to structure and staff nominating committees.

There will be election costs to include voting on the resolution in the next general election.

SIGNIFICANT ISSUES

SJR2 would require the New Mexico Governor to nominate non-student Board of Regents members from a list provided by a nominating committee established by law. SJR2 states that the New Mexico Legislature would determine the appointment, terms, powers, and duties of the nominating committees. No more than 50 percent (50%) of the nominating committee shall be members of the same political party.

While SJR2 shifts the authority to nominate Board of Regents members from the Executive branch to a nominating committee established by the Legislative branch, SJR2 still preserves the authority of the Governor to select nominees and, with the consent of the Senate, appoint Board of Regents members.

SJR2 calls for its proposed amendment to be submitted to the people of New Mexico for approval or rejection at the next general election or at a special election.

If SJR2 were passed, the work of the nominating committee(s) would not begin until the proposed resolution is submitted and approved by vote of the electorate.

The amendment to the Constitution proposed by SJR2 will require all state educational institutions enumerated in Article 12, Section 11 to have regents appointed via nominating committee process. The institutions are:
