The statewide gun violence prevention task force shall be composed of representatives of the crime victims reparation commission, the public education department, the higher department, the department of public safety, the department of health, the health care authority department, the children, youth and families department, the department of game and fish, the university of New Mexico, Indian nations, tribes, and pueblos of New Mexico, pueblo law enforcement and federal and local law enforcement agencies, gun advocates, and distributors and anti-domestic violence and sexual

assault groups.
