12	CREATING THE PUBLIC BANK OF NEW MEXICO; ESTABLISHING A BOARD OF
13	DIRECTORS AND THE STRUCTURE OF THE PUBLIC BANK OF NEW MEXICO;
14	PROVIDING DUTIES; PERMITTING CERTAIN INVESTMENTS; PROHIBITING

16	REQUIRING THE STATE TREASURER TO DEPOSIT AND MAINTAIN A CERTAIN

20	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
21	SECTION 1. [ <u>NEW MATERIAL</u> ] SHORT TITLESections 1
22	through 7 of this act may be cited as the "Public Banking Act".
23	SECTION 2. [ <u>NEW MATERIAL</u> ] DEFINITIONSAs used in the
24	Public Banking Act:
25	A. "bank" means the public bank of New Mexico;

B. "board" means the board of directors of the bank;

C. "director" means a member of the board; and

D. "fund" means the state banking fund and shall include all assets, liabilities, equity, income and expenses of the bank.

SECTION 3. [<u>NEW MATERIAL</u>] PUBLIC BANK OF NEW MEXICO--ESTABLISHED--BOARD OF DIRECTORS.--

A. The "public bank of New Mexico" is created as a public body politic and corporate, constituting a governmental instrumentality, which shall be chartered pursuant to the laws of the United States.

B. The bank shall constitute a public body corporate by the name set forth in the incorporation certificate and by such name may sue and be sued, have the capacity to make contracts, acquire, hold, enjoy, dispose of and convey property real and personal, accept deposits, borrow and lend money, incur indebtedness, impose fees and assessments and do any other act necessary or proper for carrying out the provisions of the Public Banking Act. The bank may serve as a fiscal agent of the state and any agency or instrumentality of the state, and the bank may serve as a fiscal agent for any local government or municipality.

C. The bank shall be governed, and all of its functions, powers and duties shall be exercised, by the board .227298.2

The board consists of eleven voting members as 3 follows: 4 two members appointed by the New Mexico (1) 5 legislative council who have successful management experience in banking finance or banking operations in a regulatory 6 7 environment; provided that the two members shall not be members 8 of the same political party; 9 one member appointed by the New Mexico (2) 10 legislative council who has successful community economic 11 development experience; 12 one member appointed by the New Mexico (3) 13 legislative council with at least five years of community 14 development experience working to address community needs; 15 one member appointed by the governor who (4) 16 has successful management experience in banking finance or 17 banking operations in a regulatory environment or who is an 18 entrepreneur with successful, sophisticated business borrowing 19 experience; 20 two members appointed by the governor who (5) 21 have successful community economic development experience, 22 which may be evidenced by experience with organizations; 23 one member appointed by the governor with (6)

1 the chief executive officer of the New (7) 2 Mexico finance authority; 3 the state treasurer; and (8) the secretary of economic development. 4 (9) The directors appointed pursuant to Subsection C 5 D. of this section shall be residents of the state and shall serve 6 7 for terms of four years and shall not serve more than two consecutive terms, except as provided in Subsection E of this 8 9 section. 10 The initial board shall establish membership Ε. 11 terms for the directors appointed pursuant to Subsection C of 12 this section so that: 13 four of the initial appointed members are (1)14 appointed for an initial term of two years; and 15 four of the initial appointed members are (2) 16 appointed for an initial term of four years. 17 Any person currently serving as a board member, F. 18 or equivalent position, for a community development financial 19 institution, credit union, trust or other banking institution 20 or an employee of a community development financial institution 21 or credit union shall not be eligible to serve as a director. 22 Directors shall receive per diem and mileage as G. 23 provided in the Per Diem and Mileage Act and shall receive no 24 other compensation, perquisite or allowance. 25 н. I. Directors shall elect a chair of the board.

J. If a vacancy occurs among the directors, the appointing authority of the former director shall appoint a replacement to serve out the term of that director. If a director's term expires, the director shall continue to serve until another member is appointed.

9 K. The board shall meet quarterly and at the call10 of the chair.

L. The board shall maintain minutes of all meetings of the board and maintain other appropriate records, including financial transaction records in compliance with state and federal law and adequate to provide an accurate record for audit purposes pursuant to the Audit Act.

M. Members of the board shall be subject to the Financial Disclosure Act.

N. The bank shall be subject to all applicable regulatory and reporting requirements that allow access to the federal reserve and shall obtain a blanket bond on all employees of the bank.

SECTION 4. [<u>NEW MATERIAL</u>] CHIEF EXECUTIVE OFFICER--CHIEF RISK OFFICER--DUTIES--STAFF.--

A. The chief executive officer of the bank shall be hired by the board. The position of the chief executive .227298.2 - 5 -

officer shall be a full-time position, and the chief executive officer shall not engage in any other occupation or profession or hold any other public office, appointive or elective.

The chief executive officer shall be an Β. individual qualified by experience in the field of investment management, investment risk management, corporate governance, investment accounting or finance. The chief executive officer of the bank shall direct the affairs and business of the bank, subject to the policies, control and direction of the board. The chief executive officer shall have substantial experience successfully running a financial institution of a comparable asset size or greater and shall be responsible for achieving the community and economic development purposes as described in the Public Banking Act. The chief executive officer shall be responsible for the management of the bank; its relations with creditors, banking and credit union partners and local communities; maintaining and improving the financial health and the internal operations and overall performance of the bank; and maintaining compliance of the bank with fiscal and regulatory requirements.

C. The chief executive officer shall receive a salary to be determined by the board and shall report to the board on all matters pertaining to the bank.

D. The chief risk officer of the bank shall be hired by the chief executive officer. The chief risk officer .227298.2

1 shall report to the board and to the chief executive officer 2 and shall assist the chief executive officer in strategic 3 planning to achieve the corporate objectives and regulatory expectations of the bank. The chief risk officer shall hold 4 5 the credential of a certified risk manager or an equivalent credential within that professional field. 6 7 Ε. The chief executive officer shall: 8 annually prepare a budget for the bank (1) 9 that shall be reviewed and approved by the board. Any funds 10 provided for the operating budget of the bank shall be provided 11 from bank income and equity; 12 hire all employees of the bank; (2) 13 keep accurate and complete records and (3) 14 accounts concerning all transactions involving the bank; and 15 (4) report quarterly to the board on the 16 investments made pursuant to the Public Banking Act and on the 17 available and encumbered funds of the fund. Annually, a report 18 shall be submitted no later than October 1 each year to the 19 legislative finance committee, the revenue stabilization and 20 tax policy committee and any other appropriate interim 21 legislative committees. The bank shall make the report 22 available to the public by publishing the report on the 23 internet.

(2) evaluate loan performance on the basis of both risk analysis and public benefit.

D. The chief executive officer of the bank and the board are trustees of all funds under their control.

SECTION 6. [<u>NEW MATERIAL</u>] CONFLICTS OF INTEREST--PENALTY.--

A. If any director, officer or employee of the bank has an interest, either direct or indirect, in any contract to which the bank is or is to be a party, such interest shall be disclosed to the board in writing. The director, officer or employee having such interest shall not participate in any action by the bank with respect to that contract.

B. Any person who has a conflict of interest as provided in this section and participates in any transaction involving that conflict of interest or knowingly fails to notify the bank of that conflict is guilty of a misdemeanor and upon conviction shall be sentenced pursuant to the provisions of Section 31-19-1 NMSA 1978.

SECTION 7. [<u>NEW MATERIAL</u>] STATE BANKING FUND--CREATED.--

A. The "state banking fund" is created within the state treasury. The fund consists of appropriations, capital, retained earnings, deposits and investment income of the fund. Except as otherwise provided in the Public Banking Act, money from payments of principal of and interest on loans and .227298.2

payments of principal of and interest on securities held by the bank shall be deposited in the fund. Money in the fund shall not revert to the general fund at the end of a fiscal year.

4 Β. Until the bank is chartered, the state treasurer 5 shall administer the fund, and money in the fund is 6 appropriated to the state treasurer to be used for the purpose 7 of carrying out the provisions of the Public Banking Act. 8 Disbursements from the fund shall be made by warrant of the 9 secretary of finance and administration pursuant to vouchers 10 signed by the state treasurer or the state treasurer's 11 authorized representative.

C. When the bank becomes chartered pursuant to state law:

(1)the fund shall be transferred to the bank;

the bank shall administer the fund; (2)

money in the fund is appropriated to and (3) retained by the bank for the purpose of carrying out the provisions of the Public Banking Act; and

(4) money in the fund shall be disbursed on vouchers signed by the chief executive officer of the bank or the chief executive officer's authorized representative.

SECTION 8. A new section of Chapter 6, Article 10 NMSA 1978 is enacted to read:

"[NEW MATERIAL] PUBLIC BANK OF NEW MEXICO--DEPOSITS--EXCEPTED.--

A. Chapter 6, Article 10 NMSA 1978 is not applicable to deposits made to the public bank of New Mexico expect as provided in this section.

B. Within thirty days of the incorporation of the public bank of New Mexico and the bank receiving its formal charter, the state treasurer shall make a deposit into the public bank of New Mexico in an amount of thirty-five million dollars (\$35,000,000). The state treasurer shall not withdraw the funds from the initial deposit provided for in this section, but may deposit additional funds in the public bank of New Mexico."

SECTION 9. APPROPRIATIONS.--

A. Twenty million dollars (\$20,000,000) is appropriated from the general fund to the state banking fund for expenditure in fiscal year 2025 and subsequent fiscal years to capitalize the public bank of New Mexico for the purpose of carrying out the provisions of the Public Banking Act. Any unexpended or unencumbered balance remaining at the end of a fiscal year shall not revert to the general fund.

B. One million five hundred thousand dollars (\$1,500,000) is appropriated from the general fund to the economic development department for expenditure in fiscal year 2025 and subsequent fiscal years for the purpose of establishing and chartering the public bank of New Mexico and developing the bank's lending programs.
