16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. A new section of the Children, Youth and
18	Families Department Act is enacted to read:
19	"[ <u>NEW MATERIAL</u> ] ELECTRONIC RECORDSRETENTION
20	A. Employees of the department shall only use
21	electronic devices issued by the department to employees for
22	communication related to the performance of duties within the
23	scope of their employment by the department. An employee's

B. Electronic devices issued by the department to employees shall only include software and applications that are compliant with federal, state, local, territorial and tribal data retention and protection laws.

C. By January 1, 2025, the department shall implement a system, approved by the department of information technology, that will back up on an hourly basis all electronic records generated or received by employees of the department related to the performance of their duties within the scope of their employment by the department.

D. During the term of an employee's employment by the department, and for a period of at least twenty-four years after the termination of an employee's employment by the department, the department shall retain all electronic records stored on electronic devices used by department employees and all electronic records that have been backed up from electronic devices used by department employees.

E. As used in this section:

 (1) "back up" means to electronically copy in a recoverable format to a searchable database maintained by the department all electronic records generated by or contained within an electronic device;

(2) "electronic device" means a telephone, tablet, computer, watch or similar device used to generate, .226761.3
