15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. Section 29-9-3 NMSA 1978 (being Laws 1973,
17	Chapter 225, Section 3, as amended) is amended to read:
18	"29-9-3. COMMISSION CREATEDMEMBERSHIP
19	A. There is created the "governor's organized crime
20	prevention commission". The commission shall consist of
21	[seven] <u>eight</u> members appointed by the governor with the advice
22	and [the] consent of the senate. No more than four members
23	shall belong to the same political party and at least one
24	member shall be a member of the New Mexico bar.
25	B. Persons appointed to the commission shall:

1 be of unquestioned integrity and of high (1) standing and influence within the state by virtue of their 2 3 demonstrated capacity for leadership; be selected from the various parts of the 4 (2) 5 state in such manner as to provide broad geographical representation on the commission; [and] 6 7 (3) include one tribal law enforcement 8 representative; and 9 [(3)] (4) be given a security clearance by an 10 appropriate agency designated by the governor to conduct a 11 clearance investigation. 12 C. [Members of the commission shall be appointed 13 for staggered terms of four years each, three ending on 14 December 31, 1975, two ending on December 31, 1976 and two 15 ending on December 31, 1977. Thereafter] Appointments shall be 16 made for staggered terms of four years or less so that the 17 terms of not more than three commission members expire on 18 December 31 of any year. 19 D. Members of the commission shall receive per diem 20 and mileage as provided in the Per Diem and Mileage Act and 21 shall receive no other compensation, perquisite or allowance. 22 Any vacancy on the commission shall be filled Ε. 23 for the unexpired term by the governor. A vacancy on the 24 commission shall not impair the right of the remaining members 25 to exercise all the powers of the commission, provided the
