11	PROPOSING TO AMEND THE CONSTITUTION OF NEW MEXICO TO PROVIDE
12	FOR THE CREATION OF AN INDEPENDENT REDISTRICTING COMMISSION TO
13	DEVELOP AND ADOPT REDISTRICTING PLANS AS PROVIDED BY LAW FOR

17	BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. It is proposed to amend Article 4, Section 3
19	of the constitution of New Mexico to read:
20	"A. Senators shall not be less than twenty-five
21	years of age and representatives not less than twenty-one years
22	of age at the time of their election. If any senator or

1 elected, then [he] the senator or representative shall be 2 deemed to have resigned and [his] a successor shall be selected 3 as provided in <u>Article 4</u>, Section 4 of this [article] 4 constitution. No person shall be eligible to serve in the 5 legislature who, at the time of qualifying, holds any office of trust or profit with the state, county or national governments, 6 7 except notaries public and officers of the militia who receive 8 no salary.

B. The senate shall be composed of no more than forty-two members elected from single-member districts.

C. The house of representatives shall be composed of no more than seventy members elected from single-member districts.

[D. Once following publication of the official report of each federal decennial census hereafter conducted, the legislature may by statute reapportion its membership.]"

SECTION 2. It is proposed to amend Article 20 of the constitution of New Mexico by adding a new section to read:

"A. By September 1 of the year of the federal decennial census, an independent redistricting commission shall be established to develop and adopt plans for the redistricting of congressional districts, state legislative districts and the districts of other districted state offices. The commission shall file its adopted plans with the secretary of state within six months of the release of redistricting data by the United

States census bureau. Plans adopted by the commission shall determine the districts for use in the succeeding primary and general elections for each respective body.

Β. The redistricting commission shall consist of nine members who are registered qualified electors of New Mexico, three of whom are members of the largest political party, three of whom are members of the second largest political party and three of whom are not members of either of the two largest political parties and that, as closely as possible, mirrors the geographic and demographic makeup of the Two-thirds of members will be randomly selected, using state. statistically accepted weighting methodology, from applications received by the secretary of state. To achieve the geographic and demographic makeup of the state, the final third will be selected by majority vote by the randomly selected commission members from among the applicant pool.

C. Districts shall be drawn using traditional redistricting principles, shall be nonpartisan and incumbent neutral and shall not result in minority vote dilution when a minority group is sufficiently large and geographically compact to constitute a majority in a single-member district and is politically cohesive and the non-minority group votes sufficiently as a block to usually enable it to defeat the minority group's preferred candidate.
