### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Synopsis: SB 552 amends the Public School Code to require school boards and governing bodies of charter schools to establish public school library policies by September 1, 2025, that protect against harassment and discrimination in regards to disability, race, creed, color, sex, sexual orientation, gender identity, gender expression, family composition, religion, age, national origin or ancestry, with respect to the author, content and intended audience of a library resource in print or non-print format. Further the bill requires adoption of a reconsideration of library resources policy by September 1, 2025, that would allow only parents of students to challenge library materials, with the school board or governing body reviewing and making a final determination based on the library's established collection development and maintenance policy. Library materials cannot be reviewed more than once every two years, and cannot be removed from access by students while under review. A library staff member cannot be retaliated against for refusing to remove library materials under review. A request for reconsideration is a public record.
