SECTION 1. Section 2-1-1 NMSA 1978 (being Laws 1919, Chapter 22, Section 1) is amended to read:

"2-1-1. RESIGNATION OF MEMBERS--NOTICE OF VACANCIES.--

SJC→SRC→A.←SRC←SJC SJC→A.←SJC Any member of the legislature [of the State of New Mexico] may resign [his] the member's office by filing a written statement of [such] resignation with the secretary of state [of New Mexico] SJC→SRC→and with the county commissioners of all counties in the district of the vacant legislative office←SRC←SJC , and upon the filing of [such] the resignation, the office of senator or representative filled by the person [so] resigning shall become vacant.

SJC→SRC→B. Within fifteen days of receipt of a notice of a vacancy of a legislative office, the secretary of state shall provide written notice to the county commissioners of all counties in the district of the vacant legislative office.←SRC←SJC

SJC→B. Within Sf12→fifteen←Sf12 Sf12→five←Sf12 days of receipt of a notice of a vacancy of a legislative office, the secretary of state shall provide written notice to the Sf12→governor, the presiding officer of the respective legislative chamber and the←Sf12 county commissioners of all counties in the district of the vacant legislative office.←SJC "
