15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. [ <u>NEW MATERIAL</u> ] SHORT TITLEThis act may be
17	cited as the "Behavioral Health Medicaid Waiver Act".
18	SECTION 2. [ <u>NEW MATERIAL</u> ] DEFINITIONSAs used in the
19	Behavioral Health Medicaid Waiver Act:
20	A. "behavioral health disability" means serious
21	mental illness, serious emotional disturbance, substance use
22	disorder or brain injury whenever that condition:
23	(1) substantially impairs a person's ability
24	to manage the person's own affairs; or
25	(2) makes a person eligible to receive

17	years of age or older of sufficient duration to meet diagnostic
18	criteria that results in functional impairment that
19	substantially interferes with or limits one or more major life
20	activities; and
21	E. "substance use disorder" means dependence on or
22	abuse of alcohol, illicit drugs or psychotherapeutics,
23	including prescription pain relievers, sedatives, tranquilizers
24	or stimulants, in the past twelve months based on assessments
25	of individual diagnostic criteria from the current edition of

1 the Diagnostic and Statistical Manual of Mental Disorders 2 published by the American psychiatric association. 3 SECTION 3. [NEW MATERIAL] HEALTH CARE AUTHORITY DUTIES--4 PERSONS WITH BEHAVIORAL HEALTH DISABILITIES. --5 Α. Subject to the availability of appropriations provided expressly for this purpose, the health care authority 6 7 shall: 8 acquire, provide or coordinate support and (1)9 services for persons with behavioral health disabilities; 10 (2) enter into contracts and provider 11 agreements with agencies and persons capable of providing 12 support and services to persons with behavioral health 13 disabilities: and 14 establish advisory councils and task (3) 15 forces as necessary to guide the development of and to review 16 the operation of support and services to persons with 17 behavioral health disabilities. 18 Β. Support and services shall be provided by the 19 health care authority based on individual support and service 20 plans developed by an interdisciplinary team. The team is 21 responsible for collectively evaluating a person's needs and 22 developing an individual support and service plan to meet the 23 needs. 24 C. The health care authority shall: 25 (1) solicit the involvement of persons with

SECTION 4. [<u>NEW MATERIAL</u>] TEMPORARY PROVISION--DUTIES OF HEALTH CARE AUTHORITY--MEDICAID WAIVER PROGRAM.--

A. The health care authority shall immediately conduct monthly meetings with persons with behavioral health disabilities and their family members, providers of behavioral health services, the university of New Mexico, advocates for persons with behavioral health disabilities and county and municipal officials who are serving persons with behavioral health disabilities to determine the best way to apply to the federal centers for medicare and medicaid services for authorization to operate a medicaid waiver program for persons with behavioral health disabilities. The meetings shall continue until the health care authority has submitted an .229326.3

application to the federal centers for medicare and medicaid 2 services for authorization to operate a medicaid waiver program 3 for residents of New Mexico with behavioral health 4 disabilities.

5 The health care authority shall retain a Β. 6 consulting entity to assist the health care authority in the 7 development of an application to the federal centers for 8 medicare and medicaid services for authorization to operate a 9 medicaid waiver program for persons with behavioral health 10 disabilities.

No later than December 31, 2025, the health care C. authority shall submit an application to the federal centers for medicare and medicaid services for authorization to operate a medicaid waiver program for persons with behavioral health disabilities, seeking authorization to operate a medicaid waiver program for persons with behavioral health disabilities that is comparable to New Mexico's home and community-based medicaid waiver programs for persons with developmental disabilities.

SECTION 5. APPROPRIATION. -- One million one hundred thousand dollars (\$1,100,000) is appropriated from the general fund to the health care authority for expenditure in fiscal years 2026 and 2027 to retain a qualified consultant to guide the health care authority in the development of an application to the federal government for the creation of a behavioral .229326.3
