### SUMMARY

### Synopsis of SHPAC Substitute for Senate Bill 247

The Senate Health and Public Affairs Committee substitute for Senate Bill 247 (SB247) requires the Public Education Department (PED) report on specific demographic data from department-approved summative assessments for science, math, and English language arts, by September 1 of each year. It also requires these results to be published on a website in a user-friendly format.

### FISCAL IMPLICATIONS

SB247 does not include an appropriation. SB247 would require that PED shorten its timeline for getting assessment data ready for the public; this could require more efficient verification procedures, increased manpower, or shorter appeal windows. PED's assessment, research, and accountability divisions currently house 10 FTE responsible for verifying the accuracy of assessment data for accountability purposes across 868 public schools. According to PED's FY25 accountability schedule (see Attachment 1), the following assessment-related events occur during a year:



- 1. Student test windows open between January and May;
- 2. Local educational agencies (LEAs) and PED validate pre- and post-reporting data in May;
- 3. Final assessment vendor files are sent to PED between May and July;
- 4. PED cleans and validates data in July;
- 5. Individual student reports become available between April and August;
- 6. Coordinator trainings, LEA validation of data, and LEA appeals of data occur between September and October; and
- 7. PED publishes data publicly on NMVistas in November.

It is unclear how much PED would be able to expedite processes with staff resources or move up deadlines for assessment activities or the extent to which LEAs and PED vendors could meet an expedited timeline. This analysis assumes that, at maximum, PED would need to double the number of its assessment, research, and accountability FTE to increase capacity for a truncated schedule. Other costs may include changes to vendors and system upgrades. The LESC, LFC, and executive budget recommendations include between \$12.8 million and \$13 million for standards-based assessments for FY26, over a 28 percent increase from the prior year, which could be used to address some of these costs.

### SIGNIFICANT ISSUES

Families, teachers, schools, community partners and legislators need timely data to make informed enrollment decisions, address student needs, and evaluate progress. Current statute (22-2C-4 NMSA 1978) requires PED send assessment data to schools by August 5 so schools can make informed decisions about student placement. LEAs are encouraged to share these scores with families. Section 22-2C-11 NMSA 1978 requires PED publish data after verification by November 15 of each year, two and a half months after Senate Bill 247's proposed September 1 deadline; in practice, PED sometimes posts assessment data even later than November 15<sup>th</sup>. Last year, PED did not publish finalized results until December 19<sup>th</sup>. According to PED, the verification process allows school districts and charter schools to review and correct any demographic, accommodation, and test result records. PED uses this process to verify enrollment of test takers and ensure they are counted at the correct location for accountability purposes. It may become easier to validate data with improved data systems, but currently, New Mexico is one of the slowest states to publish assessment data. See the LESC chart below.



Recent LESC and LFC evaluations note issues with incorrect, untimely, and difficult-to-analyze data. Making data available sooner, which some other states can do, makes it easier for stakeholders to respond in real time. But if PED is not able to meet the accelerated timeline, the department could consider publishing preliminary data. PED provided preliminary data to LESC and LFC last year to complete an analysis on statewide trends with the understanding that changes would occur during the validation process. A similar caveat could be provided to the general public. This level of transparency and ability to see preliminary and final data sets and how they change might even be useful for stakeholders.

### **ADMINISTRATIVE IMPLICATIONS**

The bill shortens a timeline that PED already has difficulty meeting so they may require additional resources to meet it. The department may need to hire additional staff, change vendors, and upgrade systems to meet the deadline outlined in this bill.

# CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

SB247 relates to House Memorial 2, which convenes a working group led by LESC to study data governance and artificial intelligence in the 2025 interim.
