Synopsis:

Proposes that New Mexico join in the Counseling Compact, a contract among states allowing professional counselors licensed and residing in a compact member state to practice in other compact member states without need for multiple licenses, while preserving the state's regulatory authority. This bill is the same one introduced in 2025 HB217 and 2024 SB98.
