**SECTION III: NARRATIVE****BILL SUMMARY**

Synopsis: HB50 proposes the Social Work Licensure Interstate Compact, allowing licensed social workers to obtain multistate licensure that authorizes practice across multiple participating states, while maintaining a single home-state license. This bill establishes a Social Work Licensure Compact Commission to oversee implementation, administration, and coordination among member states.

This commission would be tasked with developing a coordinated data system to identify each multistate licensure applicant with a unique identifier and facilitate information-sharing related to licensure and disciplinary actions. As part of their scope, the commission may promulgate rules necessary to implement the provisions of this compact.

The legislation also provides specific provisions for military members and their spouses to maintain licensure portability during relocations. Additionally, HB50 amends the Social Work Practice Act to expand scope of practice and require state and federal criminal history background checks, including fingerprint-based checks, for multistate licensure.

This bill does not contain an effective date and, as a result, would go into effect 90 days after the Legislature adjourns if enacted, or May 20, 2026.
