SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

HB 59 amends Section 31-18-15 NMSA 1978, increasing the basic sentence for a second-degree felony resulting in death from eighteen to twenty-five years of imprisonment.

FISCAL IMPLICATIONS

There would be minimum fiscal impact for District Attorneys or Public Defenders since funding is already in place to prosecute and defend second degree felonies resulting in death.

SIGNIFICANT ISSUES

This would make the criminal code more consistent. Individuals that are convict of a second drug trafficking are sentence to 18 years of mandatory where as a person that kills somebody can get up to 15 years in the current sentencing structure of the criminal code.

The maximum sentence under HB 59 is still in the discretion of the judge.
