SECTION III: NARRATIVE**BILL SUMMARY**

Synopsis: HM1 requests the LFC to create a task force of eighteen (18) members to include: bipartisan legislative representation, key Children, Youth & Families (CYFD) staff, subject-matter experts in social work, behavioral health, foster care and juvenile justice, tribal government, stakeholders and advocacy groups, to study the feasibility and implications of amending the Constitution of NM in order to create a CYFD as an independent department outside the direction of the Office of the Governor. It further establishes an independent governing commission to hire an executive director to assume management and operations of the department. LFC Recommendations are due November 15, 2026, for consideration during the first session of the 58th legislature.

OTHER SUBSTANTIVE ISSUES

The memorial anticipates implementing this approach would likely require a constitutional amendment to create a commission appointed by the Legislature, which could raise separation-of-powers and accountability considerations because the New Mexico Constitution separates the powers of the legislative and executive branches absent express constitutional authorization. For

that reason, any proposal emerging from the study would benefit from careful legal review and clear delineation of appointment/oversight authority, transition planning, and the potential impact on coordination with other state agencies- issues the memorial itself asks the task force to examine, including potential legal and constitutional issues.
