SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

- House Memorial (SM) 39 seeks to enhance statewide coordination and transparency regarding sexual assault examination kit processing.
- Requests the Secretary of Public Safety and the Executive Director of the New Mexico Coalition of Sexual Assault Programs to convene and co-chair a task force to study the current state of sexual assault examination kits in New Mexico.
- Defines task force membership to include the State Auditor and Attorney General (or designees), representatives from regional rape crisis centers and sexual assault nurse examiner (SANE) programs, the statewide SANE coordinator, and representatives from the Department of Public Safety and Albuquerque Police Department.
- Directs the task force to report updates and recommendations to interim and legislative committees dealing with courts, corrections, and justice and to the Legislative Health and Human Services Committee.
- Requests the task force begin meeting in July 2026 but specifies no meeting cadence.

FISCAL IMPLICATIONS

The task force's reporting obligations include:

- Statewide progress in processing sexual assault examination kits to meet timelines defined in Section 30-9-21 NMSA 1978.
- The adequacy of services available to survivors
- Potential solutions to address current challenges in processing sexual assault examination kits
- Legislative recommendations

Producing these reports will result in unplanned costs. However, beyond identifying task force participants, HM39 does not define roles, responsibilities, timing, or frequency associated with the reporting, making costs incurred on individual organizations difficult to estimate.
