## **SECTION III: NARRATIVE**

### **BILL SUMMARY**

Synopsis: This memorial makes the following requests:

- That the Legislative Finance Committee convene a working group to study state and federal funds administered by the Children, Youth, and Families Department to support domestic violence services in New Mexico;
- That the working group so convened study all state and federal funds administered by CYFD that are for the purpose of supporting domestic violence services in New Mexico;
- That the working group include representatives from the Department of Finance and Administration, the Legislative Finance Committee, Domestic Violence Providers around the state, and the New Mexico Coalition Against Domestic Violence;
- That the working group produce a report, and that this report include;
  - An accounting of the state and federal domestic violence related funds administered by CYFD;
  - An examination of how the funds are administered and distributed, including administrative structures, pass-through arrangements and timelines;
  - An identification of entities that received such funds and the amount received by each entity; and
  - A recommendation regarding what level of funding is needed to fully fund domestic violence support services statewide with a focus on funding support being directed to domestic violence providers.

### **FISCAL IMPLICATIONS**

There is no appropriation contained within this memorial. CYFD is not identified as a member of the working group, and as such there are no fiscal implications for CYFD. In the event that CYFD is invited to be a member of the working group, there will be fiscal implications, but in the absence of any deadline for completion of the study, CYFD will be able to absorb those implications with existing resources.

### **SIGNIFICANT ISSUES**

This working group does not include CYFD, or other important partners, such as the Coalition to Stop Violence Against Native Women (CSVANW). The failure to include CSVANW has the potential to silence the voices of providers and individuals representing or belonging to the Nations, Pueblos and Tribes that reside throughout the boundaries of the state of New Mexico.

The failure to include representation from CYFD will result in lack of subject matter expertise to how the agency administers the various funds indicated in the study.

There is no date of completion or delivery for the report, and no identification of who the report will be provided to once completed.

CYFD has no performance measures concerning this study.
