AN ACT

RELATING TO CHILD WELFARE; AMENDING THE CHILDREN, YOUTH AND
FAMILIES DEPARTMENT ACT TO CREATE THE FOSTER CARE PLUS PILOT
PROJECT; DIRECTING THE CHILDREN, YOUTH AND FAMILIES DEPARTMENT
AND THE HEALTH CARE AUTHORITY TO COLLABORATE TO CONTRACT WITH
APPROPRIATE CLINICAL EXPERTS TO DEVELOP AND IMPLEMENT THE
THREE-YEAR PILOT PROJECT IN DONA ANA, CHAVES, SAN JUAN,
MCKINLEY, BERNALILLO, SANTA FE AND EDDY COUNTIES; PROVIDING
THAT THE PILOT PROJECT WILL SERVE ELIGIBLE CHILDREN IN STATE
CUSTODY AND THEIR FAMILIES AND WILL INCLUDE ENHANCED FOSTER
CARE SERVICES; PROVIDING ELIGIBILITY REQUIREMENTS; ALLOWING
PLACEMENT GAP INCENTIVES; REQUIRING EVIDENCE-BASED ASSESSMENTS
AND TREATMENT MODELS; DEFINING TERMS; PROVIDING FOR SPECIALIZED
INCENTIVE TRACKS; MAKING AN APPROPRIATION.

1 SECTION 1. A new section of the Children, Youth and
2 Families Department Act is enacted to read:

3 "[NEW MATERIAL] FOSTER CARE PLUS PILOT PROJECT CREATED--
4 PURPOSE--PILOT PROJECT REQUIREMENTS--ELIGIBILITY--
5 ADMINISTRATION.--

6 A. The "foster care plus pilot project" is created
7 within the department as a three-year pilot project for
8 children in state custody and their families within Dona Ana,
9 Chaves, San Juan, McKinley, Bernalillo, Santa Fe and Eddy
10 counties. The purpose of the pilot project is to provide
11 children with in-home or home-like placements along with
12 short-term stabilization support and services and crisis
13 response and bridge placement when appropriate.

14 B. The department, in collaboration with the health
15 care authority, shall contract with appropriate clinical
16 experts with demonstrated experience in evidence-based
17 treatment models and stabilizing placements for children with
18 acute behavioral health or mental health needs. Contractors
19 selected to provide services pursuant to this section shall
20 work with the department and the health care authority to
21 develop and implement the foster care plus pilot project that
22 uses home-like settings intended to reduce placement
23 disruptions, including therapeutic foster homes. The pilot
24 project shall provide the following evidence-based treatment
25 and enhanced foster care support and services:

- 1 (1) twenty-four-hour crisis intervention;
2 (2) monthly in-home caseworker visits to
3 discuss child functioning, parenting techniques and caregiver
4 self-care;
5 (3) weekly in-home child therapy;
6 (4) monthly in-home family therapy;
7 (5) parent training focusing on therapeutic
8 communication and trauma-informed crisis management; and
9 (6) treatment team meetings to collaborate on
10 a child's individualized service and support plan.

11 C. To fill placement gaps for children who require
12 short-term stabilization or behavioral health support services,
13 the department, in collaboration with the health care
14 authority, shall establish financial and pilot project
15 incentives to expand placement options, including small,
16 home-like facilities or therapeutic foster homes. The
17 incentives may include:

- 18 (1) enhanced contract rates for qualified
19 therapeutic foster parents or home-like facility providers;
20 (2) start-up financial support for small,
21 home-based or residential placement settings that serve six or
22 fewer children; and
23 (3) bonus payments for placement providers who
24 accept children participating in specialized incentive tracks
25 as provided in Subsection E of this section.

1 D. A child's participation in the foster care plus
2 pilot project shall be based upon the child's clinical
3 assessment at the time of entry into the pilot project and as
4 may be required or recommended after initial entry. Children
5 with a history of frequent placements, a risk of placement
6 disruption or a clinical diagnosis requiring higher levels of
7 therapeutic support shall be prioritized for pilot project
8 participation.

9 E. The foster care plus pilot project shall include
10 specialized incentive tracks developed for children
11 participating in the pilot project who:

- 12 (1) have acute behavioral needs;
- 13 (2) are over twelve years of age;
- 14 (3) are part of a sibling group; or
- 15 (4) require short-term stabilization

16 placements of seven to thirty days as a bridge to permanency or
17 long-term placement.

18 F. Upon implementation, the foster care plus pilot
19 project shall be administered by the department with continuing
20 assistance as appropriate by the health care authority, and on
21 or before November 1, 2026 and by November 1 of each year
22 thereafter, the department shall submit an annual report
23 detailing the performance and outcomes of the pilot project to
24 the legislative finance committee and the legislative health
25 and human services committee.

1 G. For the purposes of this section:

2 (1) "evidence-based treatment" means a
3 clinical or therapeutic intervention that is recognized by a
4 national or state child welfare or behavioral health authority
5 and is validated by research and supported by outcomes data;

6 (2) "specialized incentive track" means a
7 structured path that provides a child extra support and
8 services and includes enhanced payments or benefits to the
9 foster parents or provider who cares for the child; and

10 (3) "therapeutic foster home" means a licensed
11 foster home or kinship placement approved to provide in-home
12 behavioral health services."

13 SECTION 2. APPROPRIATION.--Two million five hundred
14 thousand dollars (\$2,500,000) is appropriated from the general
15 fund to the children, youth and families department for
16 expenditure in fiscal years 2027 through 2029 to, in
17 collaboration with the health care authority, contract with
18 appropriate clinical experts to develop, implement and
19 administer the foster care plus pilot project in Dona Ana,
20 Chaves, San Juan, McKinley, Bernalillo, Santa Fe and Eddy
21 counties. Any unexpended balance remaining at the end of
22 fiscal year 2029 shall revert to the general fund.
