HOUSE BILL 332

57TH LEGISLATURE - STATE OF NEW MEXICO - SECOND SESSION, 2026

AN ACT

RELATING TO CAPITAL EXPENDITURES; REAUTHORIZING OR
REAPPROPRIATING BALANCES, EXPANDING OR CHANGING PURPOSES,
EXTENDING EXPENDITURE PERIODS AND CHANGING AGENCIES;
ESTABLISHING CONDITIONS FOR THE REVERSION OR TRANSFER OF
UNEXPENDED BALANCES OF APPROPRIATIONS MADE BY THE LEGISLATURE
IN PRIOR YEARS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. SEVERANCE TAX BONDS--REAUTHORIZATION AND
REAPPROPRIATION OF PROCEEDS.--For a prior year severance tax
bond appropriation for a capital outlay project as provided in
this act, the legislature may reauthorize or reappropriate the
unexpended balance of the severance tax bond proceeds, expand
or change the project purpose, extend the expenditure period,
change the recipient agency or establish conditions for the

1 reversion or transfer of the unexpended balance due to:

2 A. the inability of a project to use the proceeds
3 of the severance tax bonds for the purpose originally
4 authorized by law;

5 B. the completion of a project without the use of
6 the appropriated severance tax bond proceeds;

7 C. unanticipated delays in the need for or
8 expenditure of the severance tax bond proceeds for the purpose
9 originally authorized by law; or

10 D. required compliance with the federal Internal
11 Revenue Code of 1986, as amended.

12 SECTION 2. SEVERANCE TAX BONDS--REVERSION OF PROCEEDS.--

13 A. Except as otherwise provided in another section
14 of this act:

15 (1) the unexpended balance from the proceeds
16 of severance tax bonds issued for a project that has been
17 reauthorized in this act shall revert to the severance tax
18 bonding fund:

19 (a) at the end of the expenditure period
20 as set forth in this act, if the expenditure period is changed
21 in this act; or

22 (b) if the expenditure period is not
23 changed in this act, pursuant to the time frame set forth in
24 the law that originally authorized the severance tax bonds or
25 the time frame set forth in any law that has previously

1 reauthorized the expenditure of the proceeds, whichever is
2 later; and

3 (2) all remaining balances from the proceeds
4 of severance tax bonds issued for a project that has been
5 reauthorized in this act shall revert to the severance tax
6 bonding fund three months after the reversion date for the
7 unexpended balances.

8 B. For the purpose of this section, "unexpended
9 balance" means the remainder of an appropriation after
10 reserving for unpaid costs and expenses covered by binding
11 written obligations to third parties.

12 SECTION 3. GENERAL FUND AND OTHER FUND APPROPRIATIONS--
13 REVERSIONS.--

14 A. Except as otherwise provided in another section
15 of this act:

16 (1) the unexpended balance of an appropriation
17 from the general fund or other state fund that has been changed
18 in this act shall revert:

19 (a) at the end of the expenditure period
20 as set forth in this act, if the expenditure period is changed
21 in this act; or

22 (b) if the expenditure period is not
23 changed in this act, pursuant to the time frame set forth in
24 the law in which the original appropriation was made or the
25 time frame set forth in any law that has previously changed the

1 appropriation, whichever is later; and

2 (2) all remaining balances of an appropriation
3 from the general fund or other state fund that has been changed
4 in this act shall revert three months after the reversion date
5 for the unexpended balance.

6 B. Except as provided in Subsection C of this
7 section, the balance of an appropriation made from the general
8 fund or other state fund shall revert pursuant to Subsection A
9 of this section to the originating fund.

10 C. The balance of an appropriation made from the
11 general fund or other state fund to the Indian affairs
12 department or the aging and long-term services department for a
13 project located on lands of an Indian nation, tribe or pueblo
14 shall revert pursuant to Subsection A of this section to the
15 tribal infrastructure project fund.

16 D. For the purpose of this section, "unexpended
17 balance" means the remainder of an appropriation after
18 reserving for unpaid costs and expenses covered by binding
19 written obligations to third parties.

20 SECTION 4. LOS OJOS MUTUAL DOMESTIC WATER CONSUMERS' AND
21 SEWAGE WORKS ASSOCIATION AND BRAZOS MUTUAL DOMESTIC WATER
22 CONSUMERS ASSOCIATION WATER SYSTEM IMPROVEMENT--EXTEND TIME--
23 SEVERANCE TAX BONDS.--The time of expenditure for the
24 department of environment project in Subsection 75 of Section
25 22 of Chapter 53 of Laws 2022 to plan, design, construct and

1 renovate wells in Los Ojos mutual domestic water consumers' and
 2 sewage works association and Brazos mutual domestic water
 3 consumers association in Rio Arriba county is extended through
 4 fiscal year 2028.

5 **SECTION 5. ATRISCO DRIVE CONSTRUCTION--EXTEND TIME--**
 6 **SEVERANCE TAX BONDS.--**The time of expenditure for the
 7 department of transportation project in Subsection 2 of Section
 8 36 of Chapter 53 of Laws 2022 to plan, design, construct and
 9 improve Atrisco drive, including drainage, curb and gutter and
 10 sidewalks, in Bernalillo county is extended through fiscal year
 11 2028.

12 **SECTION 6. BERNALILLO COUNTY TOWN OF ATRISCO LAND GRANT-**
 13 **MERCED MONUMENT AND MEMORIAL PLAZA PARK--EXTEND TIME--SEVERANCE**
 14 **TAX BONDS.--**The time of expenditure for the local government
 15 division project in Subsection 9 of Section 35 of Chapter 81 of
 16 Laws 2020 for which the time of expenditure was previously
 17 extended in Laws 2024, Chapter 65, Section 35 to acquire land
 18 and to plan, design and construct an Atrisco land grant-merced
 19 monument and memorial plaza park in the Atrisco community in
 20 Bernalillo county is extended through fiscal year 2028.

21 **SECTION 7. ATRISCO VISTA BOULEVARD CONSTRUCTION--EXTEND**
 22 **TIME--SEVERANCE TAX BONDS.--**The time of expenditure for the
 23 department of transportation project in Subsection 3 of Section
 24 36 of Chapter 53 of Laws 2022 to acquire rights of way for and
 25 to plan, design and construct the realignment of Atrisco Vista

1 boulevard, from Double Eagle airport to paseo del Norte
2 boulevard NW, including the intersection of Atrisco Vista
3 boulevard and paseo del Norte boulevard NW, in Bernalillo
4 county is extended through fiscal year 2028.

5 **SECTION 8. ATRISCO VISTA BOULEVARD EXTENSION**

6 IMPROVEMENT--EXTEND TIME--SEVERANCE TAX BONDS.--The time of
7 expenditure for the department of transportation project
8 originally authorized in Subsection 1 of Section 38 of Chapter
9 81 of Laws 2020 for which the time of expenditure was
10 previously extended in Laws 2024, Chapter 65, Section 3 to
11 acquire rights of way for and to plan, design, construct,
12 extend and improve Atrisco Vista boulevard, including bike
13 lanes, in Bernalillo county is extended through fiscal year
14 2028.

15 **SECTION 9. BERNALILLO COUNTY AFFORDABLE HOUSING PROJECT**

16 IMPROVEMENT--EXTEND TIME--SEVERANCE TAX BONDS.--The time of
17 expenditure for the department of transportation project in
18 Subsection 5 of Section 36 of Chapter 53 of Laws 2022 to plan,
19 design, construct and equip sanitary sewer, storm drainage and
20 required road infrastructure for an affordable housing project
21 at 98th street and Gibson boulevard SW in Bernalillo county is
22 extended through fiscal year 2028.

23 **SECTION 10. BERNALILLO COUNTY SENIOR AFFORDABLE HOUSING**

24 CONSTRUCTION--CHANGE TO AFFORDABLE HOUSING COMPLEX
25 CONSTRUCTION--CHANGE AGENCY--EXTEND TIME--GENERAL FUND.--The

1 unexpended balance of the appropriation to the aging and long-
 2 term services department in Subsection 1 of Section 16 of
 3 Chapter 159 of Laws 2025 to acquire and to plan, design and
 4 construct affordable housing complexes for low-to-moderate-
 5 income senior citizens in Bernalillo county shall not be
 6 expended for the original purpose but is appropriated to the
 7 local government division to acquire property for and to plan,
 8 design, purchase, construct, improve and equip affordable
 9 housing complexes for low-to-moderate-income residents in
 10 Bernalillo county. The time of expenditure is extended through
 11 fiscal year 2028.

12 **SECTION 11. BERNALILLO COUNTY ALAMEDA DRAIN TRAIL**
 13 **CONSTRUCTION--EXTEND TIME--GENERAL FUND.--**The time of
 14 expenditure for the local government division project in
 15 Subsection 9 of Section 33 of Chapter 159 of Laws 2025 to plan,
 16 design, construct and renovate the Alameda drain trail in
 17 Bernalillo county is extended through fiscal year 2028.

18 **SECTION 12. BERNALILLO COUNTY CENTRO SAVILA BUILDING**
 19 **PURCHASE--EXTEND TIME--SEVERANCE TAX BONDS.--**The time of
 20 expenditure for the local government division project in
 21 Subsection 7 of Section 30 of Chapter 53 of Laws 2022 to
 22 purchase a building and to plan, design, construct and renovate
 23 a mental health and suicide prevention facility for immigrant
 24 and refugee families in Bernalillo county is extended through
 25 fiscal year 2028.

2 **VEHICLE AND EQUIPMENT PURCHASE--EXTEND TIME--GENERAL FUND.--**The
3 time of expenditure for the local government division project
4 in Subsection 15 of Section 28 of Chapter 66 of Laws 2024 to
5 purchase, deliver and equip vehicles and storage containers for
6 a statewide flamenco educational program in Bernalillo county
7 is extended through fiscal year 2028.

8 **SECTION 14. BERNALILLO COUNTY HEALTH CARE SERVICE PLAN--**
9 **CHANGE TO HEALTH CARE FACILITY EQUIPMENT AND INFORMATION**
10 **TECHNOLOGY PURCHASE--EXTEND TIME--GENERAL FUND.--**The unexpended
11 balance of the appropriation to the local government division
12 in Subsection 18 of Section 28 of Chapter 66 of Laws 2024 to
13 plan and design a health care facility in Bernalillo county
14 shall not be expended for the original purpose but is changed
15 to purchase and install equipment and information technology at
16 a health care facility in Bernalillo county. The time of
17 expenditure is extended through fiscal year 2028.

18 **SECTION 15. BERNALILLO COUNTY EAST MOUNTAIN FOOD PANTRY**
19 **EQUIPMENT PURCHASE--EXTEND TIME--GENERAL FUND.--**The time of
20 expenditure for the local government division project in
21 Subsection 23 of Section 28 of Chapter 66 of Laws 2024 to
22 purchase and deliver equipment for a food pantry serving low-
23 income, food-insecure individuals in the East Mountain area in
24 Bernalillo county is extended through fiscal year 2028.

25 **SECTION 16. BERNALILLO COUNTY PARADISE HILLS LITTLE**

1 LEAGUE GROUNDS AND FACILITY IMPROVEMENT--EXTEND TIME--SEVERANCE
 2 TAX BONDS.--The time of expenditure for the local government
 3 division project in Subsection 17 of Section 30 of Chapter 53
 4 of Laws 2022 to plan, design, construct, install and equip
 5 improvements to the facilities and grounds used by the Paradise
 6 Hills little league, including a concrete entryway, playground,
 7 bleachers, shade structures, field and parking lighting,
 8 pavilion, landscaping and walking trails, in Bernalillo county
 9 is extended through fiscal year 2028.

10 SECTION 17. BERNALILLO COUNTY ROAD TRAFFIC CALMING
 11 INSTALLATION--EXTEND TIME--SEVERANCE TAX BONDS.--The time of
 12 expenditure for the department of transportation project in
 13 Subsection 10 of Section 36 of Chapter 53 of Laws 2022 to plan,
 14 design, construct and install traffic calming devices for roads
 15 in Bernalillo county is extended through fiscal year 2028.

16 SECTION 18. BERNALILLO COUNTY ROAD IMPROVEMENT--EXTEND
 17 TIME--SEVERANCE TAX BONDS.--The time of expenditure for the
 18 department of transportation project in Subsection 7 of Section
 19 36 of Chapter 53 of Laws 2022 to plan, design, construct and
 20 improve county roads in Bernalillo county is extended through
 21 fiscal year 2028.

22 SECTION 19. BERNALILLO COUNTY SHERIFF'S OFFICE INFRARED
 23 CAMERAS PURCHASE--EXTEND TIME--GENERAL FUND.--The time of
 24 expenditure for the local government division project in
 25 Subsection 36 of Section 28 of Chapter 66 of Laws 2024 to

1 purchase, equip and install color infrared cameras for the
2 sheriff's office metropolitan air support unit in Bernalillo
3 county is extended through fiscal year 2028.

4 **SECTION 20. BERNALILLO COUNTY SHERIFF'S DEPARTMENT**
5 INFORMATION TECHNOLOGY PURCHASE--EXTEND TIME--GENERAL
6 FUND.--The time of expenditure for the local government
7 division project in Subsection 37 of Section 28 of Chapter 66
8 of Laws 2024 to purchase, equip and install information
9 technology and crime prevention technology for the sheriff's
10 office in Bernalillo county is extended through fiscal year
11 2028.

12 **SECTION 21. BERNALILLO COUNTY SUBSTANCE ABUSE RECOVERY**
13 SERVICE EQUIPMENT PURCHASE--EXTEND TIME--GENERAL FUND.--The
14 time of expenditure for the local government division project
15 in Subsection 40 of Section 28 of Chapter 66 of Laws 2024 to
16 purchase, deliver and equip kitchen appliances, information
17 technology, furniture and equipment for a substance abuse
18 recovery program in Bernalillo county is extended through
19 fiscal year 2028.

20 **SECTION 22. BERNALILLO COUNTY TRAFFIC SIGNALS**
21 REPLACEMENT--EXTEND TIME--SEVERANCE TAX BONDS.--The time of
22 expenditure for the department of transportation project in
23 Subsection 12 of Section 36 of Chapter 53 of Laws 2022 to plan,
24 design, construct, replace, purchase, equip and install traffic
25 signals for roads in Bernalillo county is extended through

1 fiscal year 2028.

2 **SECTION 23. BERNALILLO COUNTY VETERANS TRANSITIONAL**
3 HOUSING PURCHASE--CHANGE TO TRANSITIONAL HOUSING IMPROVEMENT--
4 GENERAL FUND.--The unexpended balance of the appropriation to
5 the local government division originally authorized in
6 Subsection 155 of Section 28 of Chapter 199 of Laws 2023 and
7 reauthorized in Laws 2025, Chapter 158, Section 14 to purchase
8 and install furnishings and equipment for transitional housing
9 at the veterans integration centers in Albuquerque in
10 Bernalillo county shall not be expended for the original or
11 reauthorized purpose but is changed to plan, design, construct,
12 furnish, equip and improve transitional housing, including
13 security systems, sidewalks and landscaping, at the veterans
14 integration centers in Bernalillo county.

15 **SECTION 24. BERNALILLO COUNTY INDOOR AND OUTDOOR KENNEL**
16 PURCHASE--CHANGE TO VOCATIONAL TRAINING EQUIPMENT PURCHASE--
17 GENERAL FUND.--The unexpended balance of the appropriation to
18 the local government division in Subsection 20 of Section 28 of
19 Chapter 66 of Laws 2024 to purchase, equip and install indoor
20 and outdoor kennels for a program to assist military veterans
21 and shelter animals in Bernalillo county shall not be expended
22 for the original purpose but is changed to purchase equipment,
23 including food pantry and transport equipment and animal
24 kenneling and handling systems, for a vocational training
25 program for veterans in Bernalillo county.
