10 AN ACT

11 RELATING TO LOBBYING; PROHIBITING FORMER LEGISLATORS FROM
12 ACCEPTING COMPENSATION AS LOBBYISTS FOR A PERIOD OF TWO YEARS
13 AFTER SERVICE AS A LEGISLATOR; PROHIBITING EMPLOYERS OF
14 LOBBYISTS FROM COMPENSATING FORMER LEGISLATORS AS LOBBYISTS FOR
15 A PERIOD OF TWO YEARS AFTER SERVICE AS A LEGISLATOR; REQUIRING
16 LOBBYISTS, WHEN REGISTERING, TO FILE A STATEMENT UNDER OATH
17 STATING WHETHER THE LOBBYIST SERVED AS A LEGISLATOR IN THE PAST
18 TWO YEARS; PROVIDING NOTICE TO A LOBBYIST'S EMPLOYER IF A
19 LOBBYIST HAS SERVED AS A LEGISLATOR IN THE PAST TWO YEARS;
20 PROVIDING A PENALTY.

22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

23 **SECTION 1.** A new section of the Lobbyist Regulation Act
24 is enacted to read:

25 "[NEW MATERIAL] RESTRICTION ON LOBBYING BY STATE

1 LEGISLATORS--PENALTY.--

2 A. A former state legislator shall not accept
3 compensation as a lobbyist for a period of two years after the
4 conclusion of the former state legislator's most recent term of
5 office.

6 B. A lobbyist's employer shall not compensate a
7 former state legislator as a lobbyist for a period of two years
8 after the conclusion of the former state legislator's most
9 recent term of office.

10 C. A person who violates a provision of this
11 section shall be subject to the penalties of the Lobbyist
12 Regulation Act."

13 SECTION 2. Section 2-11-3 NMSA 1978 (being Laws 1977,
14 Chapter 261, Section 3, as amended) is amended to read:

15 "2-11-3. REGISTRATION STATEMENT TO BE FILED--CONTENTS--
16 MODIFICATION TO STATEMENT.--

17 A. In the month of January prior to each regular
18 session or before any service covered by the Lobbyist
19 Regulation Act commences, any individual who is initially
20 employed or retained as a lobbyist shall register with the
21 secretary of state by paying an annual filing fee of fifty
22 dollars (\$50.00) for each of the lobbyist's employers and by
23 filing a single registration statement under oath in an
24 electronic format as prescribed by the secretary of state that
25 states:

(1) the lobbyist's full name, permanent business address and business address while lobbying; and

(2) the name and address of each of the lobbyist's employers; and

(3) whether the lobbyist has served as a state legislator in the past two years.

C. Upon receipt of the online registration and payment, the secretary of state shall publish the registration information on the secretary of state's lobbying disclosure website, and for a lobbyist who indicated in the registration statement that the lobbyist has served as a state legislator in the past two years, the secretary of state shall notify the lobbyist's employers.

24 D. For each employer listed in Paragraph (2) of
25 Subsection A of this section, the lobbyist shall file the

1 following information:

2 (1) a full disclosure of the sources of funds

3 used for lobbying;

4 (2) an affirmation from each of the lobbyist's
5 employers authorizing the lobbyist to lobby on the employer's
6 behalf;

7 (3) a brief description of the matters in
8 reference to which the service is to be rendered; and

9 (4) the name and address of the person, if
10 other than the lobbyist or the lobbyist's employer, who will
11 have custody of the accounts, bills, receipts, books, papers and
12 documents required to be kept under the provisions of the
13 Lobbyist Regulation Act.

14 E. For each succeeding year that an individual is
15 employed or retained as a lobbyist by the same employer, and for
16 whom all the information disclosed in the initial registration
17 statement remains substantially the same, the lobbyist shall
18 file a simple annual registration renewal in January and pay the
19 fifty-dollar (\$50.00) filing fee for each of the lobbyist's
20 employers together with a short, abbreviated prescribed form for
21 renewal.

22 F. Whenever there is a modification of the facts
23 required to be set forth by this section or there is a
24 termination of the lobbyist's employment as a lobbyist before
25 the end of the calendar year, the lobbyist shall notify the

secretary of state using the electronic registration system within one week of such occurrence and shall furnish full information concerning the modification or termination. If the lobbyist's employment terminates at the end of a calendar year, no separate termination need be reported."

SECTION 3. APPLICABILITY.--The provisions of this act apply to all persons who hold the office of state legislator on or after January 1, 2027.

SECTION 4. EFFECTIVE DATE.--The effective date of the provisions of this act is January 1, 2027.
