## SUMMARY

### Synopsis of Senate Memorial 17

Senate Memorial 17 (SM17) requests the secretary of the Department of Public Safety (DPS) and the executive director of the New Mexico Coalition of Sexual Assault Programs jointly convene a task force to study the current state of sexual assault examination kits in New Mexico.

The memorial asks that the task force include members from the Office of the State Auditor and Attorney General’s office, directors of rape crisis centers, the director of DPS forensic laboratory, the coordinators of the DPS sexual assault kit initiative, the director of the Albuquerque Policy Department’s crime laboratory, and the statewide sexual assault nurse examiner coordinator.

The task force is to identify current procedures, evaluate barriers to timely testing, and assess progress in reducing the backlog of untested or unsubmitted kits. SM17 directs the task force to report its findings and progress to the appropriate legislative interim committee by November 1, 2026.

## FISCAL IMPLICATIONS

Memorials do not contain appropriations nor are they enforceable as law, but the actions it requests may carry fiscal implications for participating agencies. DPS and the New Mexico Coalition of Sexual Assault Programs may incur administrative and operational costs to support coordination, staffing, data collection, stakeholder engagement, and the preparation of a formal report.

While these activities may be absorbed within existing agency budgets, depending on scope, any extensive undertaking, particularly one involving a statewide inventory of backlogged kits or a comprehensive review of kit-handling practices, could necessitate reallocation of existing resources.

## SIGNIFICANT ISSUES

The memorial cites data from the *2024 New Mexico Crime Victimization Report* indicating that 54 percent of New Mexicans have experienced rape or sexual assault in their lifetimes. Of those surveyed, 40 percent were 12 or younger at the time of the first incident, and 28 percent required medical treatment for injuries sustained. In light of these findings, the memorial underscores the urgency of reviewing the backlog and processing practices related to sexual assault examination kits, which are often critical evidence in criminal investigations and prosecutions.

## PERFORMANCE IMPLICATIONS

DPS reports quarterly on the “*number of sexual assault examination kits not completed within one hundred eighty days of receipt of the kits by the forensic laboratory*” under the requirements of the Accountability in Government Act. While the most recent annual report from FY25 indicated the number had climbed to 1,419, the state lab received a special appropriation of \$5.7 million to outsource other cases to contract laboratories in FY25, so that the labs could focus on clearing cases that are required to be handled in-state, such as sexual assault examination kits. The lab has recently reduced vacancies by over 30 percent and hopes to complete training for the newly hired forensic scientists by the end of 2026.
