MAKING AN APPROPRIATION TO FUND A URANIUM WORKERS ASSISTANCE  
PROGRAM AT SHIPROCK IN SAN JUAN COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars  
(\$100,000) is appropriated from the general fund to the New  
Mexico office of Indian affairs for expenditure in fiscal year  
1997 for the purpose of funding a uranium workers assistance  
program located in Shiprock in San Juan county. Any unexpended  
or unencumbered balance remaining at the end of fiscal year 1997  
shall revert to the general fund.
