AN ACT

MAKING AN APPROPRIATION TO NEW MEXICO STATE UNIVERSITY FOR THE
WASTE MANAGEMENT EDUCATION AND RESEARCH CONSORTIUM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the board of regents of New Mexico state university for expenditure in fiscal year 1997 for the purpose of providing a ten percent state match for federal and private research revenues to operate the waste management education and research consortium, which trains waste management professionals and develops technologies to create new business opportunities and minimize environmental problems. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
