school districts of the state. The manual of regulations and any revision or amendments thereto shall become effective only upon approval by the state board [of education] and the legislative finance committee, filing with the state records center and publication. A copy shall also be filed with the department of finance and administration.

B. All public schools and school districts shall comply with the regulations prescribed in the manual of accounting and budgeting and shall, upon request, submit additional reports concerning finances to the department. In addition, upon request, all public schools and school districts shall file reports with the department containing pertinent details regarding applications for federal money or federal grants-in-aid or regarding federal money or federal grants-inaid received, including but not limited to details of programs, matching funds, personnel requirements, salary provisions and program numbers, as indicated in the catalog of federal domestic assistance, of the federal funds applied for and of those received.

C. The department shall develop procedures for ensuring that local school districts comply with the regulations prescribed in the manual of accounting and budgeting. The department shall require local school districts to submit annually a report on the district's internal control policies and procedures. The report shall be submitted with each budget
