AN ACT

MAKING APPROPRIATIONS TO THE CHILDREN, YOUTH AND FAMILIES
DEPARTMENT AND TO THE DEPARTMENT OF HEALTH FOR THE PROVISION OF
SERVICES FOR CHILDREN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. Seven hundred forty-six thousand dollars
(\$746,000) is appropriated from the general fund to the
children, youth and families department for expenditure in
fiscal year 1997 to provide or contract for services in the
following amounts for the following purposes:

(1) three hundred thousand dollars (\$300,000)
for the office of child development;

(2) two hundred thousand dollars (\$200,000) to
the children's trust fund; and

(3) two hundred forty-six thousand dollars (\$246,000) for child-care resource and referral programs.

B. Nine hundred thousand dollars (\$900,000) is appropriated from the general fund to the department of health for expenditure in fiscal year 1997 to provide or contract for services in the following amounts for the following purposes:

(1) four hundred thousand dollars (\$400,000) for preschool and infant evaluation programs; and

(2) five hundred thousand dollars (\$500,000) for programs serving families affected by problems caused by substance abuse during pregnancy.

C. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
