18	in fiscal years 1996 and 1997 for the purpose of funding the planning and implementation of
19	the June 1996 world indigenous peoples' conference on education in Albuquerque. Any
20	unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to
21	the general fund.
22	Section 2. EMERGENCYIt is necessary for the public peace, health and safety that
23	this act take effect immediately.
