19	A. The majority of the members of the governing body
20	may enact an ordinance imposing an excise tax on any person
21	engaging in business in the county for the privilege of engaging
22	in business. The rate of the tax shall be one-fourth of one
23	percent of the gross receipts of the person engaging in
24	business. The tax shall be imposed only once for a period of
25	not more than [two] <u>five</u> years from the effective date of the




