BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. One hundred twenty-five thousand dollars

department of public education for expenditure in fiscal year  
1997 for distribution in the following amounts for the following  
purposes:

(1) fifty thousand dollars (\$50,000) for the  
parents as teachers program in the Ruidoso municipal school  
district in Lincoln county; and

(2) seventy-five thousand dollars (\$75,000) for  
the Gavilan Canyon school adolescent day treatment center in the
