AN ACT

MAKING AN APPROPRIATION TO RESEARCH STATEWIDE LIBRARY STAFFING DATA AND EDUCATE SCHOOLS THROUGH TECHNICAL ASSISTANCE; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Thirty-five thousand dollars (\$35,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal years 1996 and 1997 for the purpose of funding the technical assistance program, which would compile and analyze statewide library staffing data, compile national research on student success and library staffing, disseminate the results statewide, serve as an advocate for professional staffing access and prepare supportive materials and presentations for applicable schools and groups. Any unexpended or unencumbered balance

remaining at the end of fiscal year 1997 shall revert to the general fund.
