MAKING AN APPROPRIATION FOR INSTRUCTIONAL SERVICES AND SUPPLIES
FOR THE AFTER-SCHOOL ACADEMY FOR AT-RISK STUDENTS AT ALAMOSA
ELEMENTARY SCHOOL IN ALBUQUERQUE IN BERNALILLO COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --One hundred thousand dollars
(\$100,000) is appropriated from the general fund to the state
department of public education for expenditure in fiscal year
1997 for the purpose of providing teaching and instructional
services and purchasing necessary supplies and materials for the
after-school academy for at-risk students at Alamosa elementary
school in Albuquerque in Bernalillo county. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997
shall revert to the general fund.
