AN ACT

MAKING AN APPROPRIATION FOR A TUTORING AND SOCIAL SERVICES YOUTH PROGRAM IN DONA ANA COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred twenty thousand dollars (\$120,000) is appropriated from the general fund to the children, youth and families department for expenditure in fiscal year 1997 for the purpose of contracting for services to provide tutoring and social services to youth in Las Cruces and Hatch who have been disenrolled, suspended or dropped from school to enable them to return to school successfully. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
