AN ACT

MAKING AN APPROPRIATION TO THE OFFICE OF THE ATTORNEY GENERAL
FOR THE PURPOSE OF IMPLEMENTING A PILOT PROJECT TO INVESTIGATE
AND PROSECUTE FRAUD SCHEMES THAT TARGET ELDERLY PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Seventy-four thousand five
hundred dollars (\$74,500) is appropriated from the general fund
to the office of the attorney general for expenditure in fiscal
year 1997 for the purpose of implementing a pilot project to
investigate and prosecute fraud schemes that target elderly
persons. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1997 shall revert to the general fund.
