AN ACT

MAKING AN APPROPRIATION FOR A SCHOOL-TO-WORK INITIATIVE IN
RETAIL SALES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars (\$100,000) is appropriated from the general fund to the labor department for expenditure in fiscal year 1997 for the purpose of funding a youth opportunities in retail sales school-to-work initiative. The initiative shall encourage high school students to consider retail sales as a career choice and to change behaviors and academic accomplishments of participating students through integration of business and student educational needs. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
