BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three million dollars
(\$3,000,000) is appropriated from the general fund to the
corrections department for expenditure in fiscal year 1997 for
the purpose of funding the expansion of community corrections
programming. Any unexpended or unencumbered balance remaining
at the end of fiscal year 1997 shall revert to the general fund.
