AN ACT

MAKING AN APPROPRIATION TO EASTERN NEW MEXICO UNIVERSITY FOR
RECRUITING AND RETENTION OF STUDENTS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty-one thousand dollars
(\$51,000) is appropriated from the general fund to the board of
regents of eastern New Mexico university for expenditure in
fiscal years 1996 and 1997 for the purpose of expanding a
student-based program to recruit and retain students at the
university. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public
peace, health and safety that this act take effect immediately.
