BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars
(\$50,000) is appropriated from the general fund to the state
department of public education for expenditure in fiscal year
1997 for the purpose of funding programs at KANW radio in the
city of Albuquerque located in Bernalillo county. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1997 shall revert to the general fund.
