AN ACT

MAKING AN APPROPRIATION TO THE ADMINISTRATIVE OFFICE OF THE DISTRICT ATTORNEYS TO PROVIDE STATEWIDE TRAINING FOR ATTORNEY AND NON-ATTORNEY STAFF.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Eighty thousand dollars (\$80,000) is appropriated from the general fund to the administrative office of the district attorneys for expenditure in fiscal year 1997 for the purpose of providing annual statewide training to attorney and non-attorney staff in district attorneys' offices. All training requests shall be approved by the administrative office of the district attorneys to ensure that all training courses be applicable to the respective job classification of the attorney and consistent with minimum continuing legal education requirements for the attorney. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
