RELATING TO CAPITAL EXPENDITURES; EXTENDING THE EXPENDITURE PERIOD FOR CERTAIN APPROPRIATIONS TO THE LIBRARY DIVISION OF THE OFFICE OF CULTURAL AFFAIRS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS-- EXTENDING EXPENDITURE PERIOD. --

A. The period of time in which the following appropriations from the general fund to the library division of the office of cultural affairs made in Laws 1994, Chapter 148, Section 44 may be expended shall be extended through fiscal year 1997:

(1) to purchase equipment, computers and communication and distribution systems for the purpose of connecting New Mexico libraries in a statewide communication network, creating a unified catalog in certain libraries and for

7 B. Any unexpended or unencumbered balance remaining  
8 at the end of fiscal year 1997 shall revert to the general fund.

9 Section 2. EMERGENCY.--It is necessary for the public
