known as the "forest land protection revolving fund". The
forest land protection revolving fund shall consist of all
receipts as provided by [Sections 68-2-22.1 and] Section 68-2-26
NMSA 1978. Expenditures may be made from the forest land
protection revolving fund upon vouchers signed by the state
forester and warrants issued by the secretary of finance and
administration for the administration and enforcement of the
