MAKING AN APPROPRIATION TO THE ATTORNEY GENERAL TO INVESTIGATE WHETHER PRICE FIXING OF ATTORNEYS' FEES EXISTS IN NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Twenty-five thousand dollars (\$25,000) is appropriated from the general fund to the attorney general for expenditure in fiscal year 1997 for the purpose of investigating whether price fixing or antitrust violations exist in the legal profession in New Mexico. The attorney general shall investigate whether certain ethical rules restrict competition, whether attorneys engage in anticompetitive actions to avoid price competition and whether it is appropriate for lawyers to restrict entry into their profession. The attorney general is encouraged to use non-attorneys in the investigation and to request voluntary disclosure of fees, salaries and

profits from attorneys statewide. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
