AN ACT

AMENDING SECTION 8-3-3 NMSA 1978 (BEING LAWS 1971, CHAPTER 138, SECTION 3, AS AMENDED) TO INCREASE THE SALARY OF THE LIEUTENANT GOVERNOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 8-3-3 NMSA 1978 (being Laws 1971, Chapter 138, Section 3, as amended) is amended to read:

"8-3-3. COMPENSATION. -- For the performance of the duties established in Section 8-3-1 NMSA 1978, the lieutenant governor shall receive an annual compensation of [~~sixty-five thousand dollars (\$65,000)~~] eighty thousand dollars (\$80,000). "

Section 2. EFFECTIVE DATE. -- The effective date of the provisions of this act is July 1, 1996.
