AN ACT

RELATING TO THE LIVESTOCK BOARD; AMENDING THE DELAYED REPEAL  
TERMINATING THE NEW MEXICO LIVESTOCK BOARD; TRANSFERRING ASSETS,  
OBLIGATIONS, POWERS AND DUTIES TO THE NEW MEXICO DEPARTMENT OF  
AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 77-2-6 NMSA 1978 (being Laws 1977,  
Chapter 256, Section 3) is amended to read:

"77-2-6. NEW MEXICO LIVESTOCK BOARD ATTACHED TO NEW MEXICO  
DEPARTMENT OF AGRICULTURE. --

A. The New Mexico livestock board is attached for  
coordinative purposes to the New Mexico department of  
agriculture. The board shall execute a memorandum of  
understanding with the director of the New Mexico department of  
agriculture identifying areas for cooperation and coordination

1 of the activities of the board with those of the New Mexico  
2 department of agriculture. Administrative and other services  
3 may be provided the board by the department pursuant to the  
4 terms of the memorandum of understanding. The board shall  
5 submit an annual report on its activities to the director. This  
6 section shall not be construed to affect the exercise of any  
7 board power or duty.

8 B. Effective July 1, 1998, the New Mexico department  
9 of agriculture shall assume the powers, duties, assets and  
10 obligations of the New Mexico livestock board. The secretary of  
11 agriculture shall establish a livestock division in the  
12 department and that division shall be responsible for oversight  
13 of the livestock industry in New Mexico. "

14 Section 2. Section 77-2-28 NMSA 1978 (being Laws 1981,  
15 Chapter 5, Section 1, as amended) is amended to read:

16 "77-2-28. TERMINATION OF BOARD LIFE--DELAYED REPEAL. --The  
17 New Mexico livestock board is terminated [~~July 1, 1999~~] July 1,  
18 1997 unless continued by the legislature pursuant to the Sunset  
19 Act. The board shall continue to operate according to all of  
20 the provisions of Chapter 77, Article 2 NMSA 1978 until [~~July 1,~~  
21 ~~2000~~] July 1, 1998 for the purpose of winding up its affairs.  
22 Effective [~~July 1, 2000~~] July 1, 1998, Chapter 77, Article 2  
23 NMSA 1978 is repealed. "
