WHEREAS, the constitution of New Mexico assigns the state corporation commission authority to regulate telephone services and set rates;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the state corporation commission be requested to analyze the factors for designating local calling areas and setting long-distance rates and access fees between local exchange companies; and

BE IT FURTHER RESOLVED that the state corporation commission attempt to establish local calling areas that closely coincide with existing communities and avoid division of 12 communities between more than one local exchange company; and 13 BE IT FURTHER RESOLVED that copies of this joint memorial 14 be transmitted to the state corporation commission.
